- 1. The Uganda National Oil Company Limited has allocated funds to be used for the Provision of a Dedicated Primary Internet Link of 100Mbps for UNOC.
- 2. The Entity invites sealed bids from eligible providers for the provision of the above services.
- 3. Bidding will be conducted in accordance with the *Open Domestic Bidding* method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

The Bid Security must be valid until **31**st **January**, **2023.** Late bids shall be rejected. Bids shall be virtually opened in the presence of bidders' representatives who choose to attend the online public bid opening session via Microsoft Teams Platform at **10:30am** on **2**nd **June 2022.**
