1. The Uganda National Oil Company Limited has allocated funds to be used for the Provision of a Dedicated Primary Internet Link of 100Mbps for UNOC.
2. The Entity invites sealed bids from eligible providers for the provision of the above services.
3. Bidding will be conducted in accordance with the ***Open Domestic Bidding*** method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
4. Interested bidders may obtain further information and inspect the bidding document at the address given at 8(a) below from 8am to 5pm.

The bidding document in English may be purchased by interested bidders on submission of a written application and upon payment of a non-refundable fee of **Ugx: 100,000/=** to the **Uganda National Oil Company Limited Account in Stanbic Bank Uganda Limited, Corporate Branch, Crested Towers on A/C No. 9030011896005**. All bids must be accompanied by a **Bid Security of UGX: 7,000,000/=** using the form as indicated in the bidding forms. The Bid Security must be valid until **31st January, 2023**. Late bids shall be rejected. Bids shall be virtually opened in the presence of bidders' representatives who choose to attend the online public bid opening session via Microsoft Teams Platform at **10:30am on 2nd June 2022**.
