

BID NOTICE UNDER OPEN INTERNATIONAL BIDDING

<u>Provision of Additional Licenses and Renewal of the existing Subscription for the Unified Threat Management System - UNOC/NCONS/21-22/00300</u>

- 1. The Uganda National Oil Company Limited (UNOC) has allocated funds to be used for Provision of Additional Licenses and Renewal of the existing Subscription for the Unified Threat Management System.
- 2. The Entity invites sealed bids from eligible providers for the provision of the above services.
- 3. Bidding will be conducted in accordance with the *Open International Bidding* method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
- 4. Interested bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 8:00 to 17:00 East African Time.
- 5. The bidding document in English may be purchased by interested bidders on submission of a written application and upon payment of a non-refundable fee of **Uganda Shillings: One hundred thousand only (100,000/=)** to the **Uganda National Oil Company Limited Account in** *Stanbic Bank Uganda Limited, Corporate Branch, Crested Towers on A/C No. 9030011896005.* Bidders should send the application letter and payment confirmation/receipt to: pl.unoc@unoc.co.ug to obtain the bidding document.
- 6. Bids must be delivered to the address below at 8(a) at or before 10:00am East African Time on 7th July 2022. All bids must be accompanied by a Bid security of Uganda shillings: Five million only (UGX: 5,000,000) using the format indicated in the bidding forms. The Bid Security must be valid until 31st January 2023. Late bids shall be rejected. Bids shall be virtually opened in the presence of bidders' representatives who choose to attend the online public bid opening session via Microsoft Teams Platform at 10:30am East African Time on 7th July 2022.

- 7. There shall be a virtual/online pre-bid meeting at **10:00am East African Time** on **2nd June 2022** using Microsoft Teams Platform. All interested eligible bidders are advised to include the email addresses of their representatives in the Application letter (in 5 above) which UNOC will use to contact and invite them for the virtual/online meeting.
