BID NOTICE UNDER OPEN DOMESTIC BIDDING

Provision of Consultancy Services for the Preliminary Design, Detailed Engineering Design, Bidding Documentation, Assistance during Bidding and Bid Evaluation for the Design of the Water Distribution Network, Wastewater Treatment and sewerage System for the Kabaale Industrial Park (KIP) including a feasibility study on supplying water to KIP from River Nile or Kafu River-Retender: UNOC/CONS/22-23/00006

1. The Uganda National Oil Company Limited (UNOC) has allocated funds to be used for acquisition of Consultancy Services for the Preliminary Design, Detailed Engineering Design, Bidding Documentation, Assistance during Bidding and Bid Evaluation for the Design of the Water Distribution Network, Wastewater Treatment and sewerage System for the Kabaale Industrial Park including a feasibility study on supplying water to KIP from River Nile or Kafu River.
2. The Entity invites sealed bids/proposals from eligible bidders and or consultants for provision of the above services.
3. Bidding will be conducted in accordance with the ***Open Domestic Bidding*** procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding document at the address given below at 8 from 8am to 5pm.
5. The bidding document in English may be purchased by interested bidders on submission of a written application and upon payment of a non-refundable fee of **Uganda Shillings: One hundred thousand only (100,000/=)** to the **Uganda National Oil Company Limited Account in Stanbic Bank Uganda Limited, Corporate Branch, Crested Towers on A/C No. 9030011896005**. Bidders should send an application letter and payment confirmation/receipt to: pl.unoc@unoc.co.ug to obtain the Bidding document.

6. Bids/Proposals must be delivered to the address in 8 below at or before **10:00am on 21st November 2022**. All proposals must be accompanied by a **Proposal Securing Declaration** that shall be valid until **30th June 2023**. Late proposals shall be rejected. Proposals shall be virtually opened in the presence of bidders' representatives who will choose to attend the online public proposal opening session via Microsoft Teams Platform at **10:40am on 21st November 2022**.
7. A Site Visit/ Pre-proposal meeting shall be held starting at **9:00am on 31st October 2022** as indicated in the procurement schedule.
