- 1. Uganda National Oil Company Limited (UNOC) has allocated funds to be used for the acquisition, support and maintenance of Real time data visualization software.

- 3. Bidding will be conducted in accordance with the *Open International Bidding* method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

The Bid Security must be valid until 31<sup>st</sup> December 2023. Late bids shall be rejected. Bids shall be virtually opened in the presence of bidders' representatives who choose to attend the online/virtual public bid opening session via Microsoft Teams Platform at 10:40am on 6<sup>th</sup> April 2023. Bidders will be required to share email addresses of their

representatives to attend the online/virtual public bid opening session prior to submission of Bids.
