3. Bidding will be conducted in accordance with the **Open Domestic Bidding** method contained in the Public Procurement and Disposal of Public Assets Act, 2021 and is open to all bidders.

The bidding document in English may be purchased by interested bidders on submission of a written application and upon payment of a non-refundable fee of **Uganda Shillings: Fifty thousand (UGX: 50,000/=)** to the **Uganda National Oil Company Limited Account in Stanbic Bank Uganda Limited, Corporate Branch, Crested Towers on A/C No. 9030011896005**. Bidders should send an application letter and payment confirmation/receipt to: pl.unoc@unoc.co.ug to obtain the Bidding document.

6. Bids must be delivered to the address below in 8(a) at or before **10:00am on 19th July 2023**. All bids must be accompanied by a **Bid Security of Uganda shillings: Five hundred thousand (UGX: 500,000)** using the format indicated in the bidding forms. The Bid Security must be valid until **7th December 2023**. Late bids shall be rejected. Bids shall be virtually opened in the presence of bidders' representatives who choose to attend the online/virtual public bid opening session via Microsoft Teams Platform at **10:40am on 19th July 2023**. Bidders will be required to share email addresses of their representatives to attend the online/virtual public bid opening session prior to submission of Bids.
