All bids must be accompanied by a Bid Security of Uganda shillings: Five Hundred Thousand (UGX: 500,000) using the format indicated in the bidding forms. The Bid Security must be valid until 31st May 2024. Late bids shall be rejected. Bids shall be virtually opened in the presence of bidders' representatives who choose to attend the online/virtual public bid opening session using Microsoft Teams Platform at 10:40am on 16th November 2023. Bidders will be required to share email addresses of their representatives to attend the online/virtual public bid opening session prior to submission of Bids.
