

BID NOTICE UNDER OPEN DOMESTIC BIDDING

PROVISION OF LICENSE RENEWAL AND SUPPORT SERVICES FOR THE UNIFIED THREAT MANAGEMENT SYSTEM: UNOC/NCONS/23-24/00144

- 1. Uganda National Oil Company Limited (UNOC) has allocated funds to be used for the acquisition of Licence renewal and support services for the Unified Threat Management System.
- 2. The Entity invites sealed bids from eligible bidders for Provision of Licence renewal and support services for the Unified Threat Management System.
- 3. Bidding will be conducted in accordance with the *Open Domestic Bidding* method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
- 4. Interested bidders may obtain further information and inspect the Bidding document at the address given below at 8(a) from **8:00am** to **05:00pm**.
- 5. The bidding document in English may be purchased by interested bidders on submission of a written application and upon payment of a non-refundable fee of **Uganda Shillings: One hundred thousand (UGX: 100,000/=)** to the **Uganda National Oil Company Limited Account in** *Stanbic Bank Uganda Limited, Corporate Branch, Crested Towers on A/C No. 9030011896005.* Bidders should send an application letter and payment confirmation/receipt to: pl.unoc@unoc.co.ug to obtain the Bidding document.
- 6. Bids must be delivered to the address below in 8(a) at or before 10:00am on 22nd November 2023. All bids must be accompanied by a Bid Security of Uganda shillings: Three million five hundred thousand (UGX: 3,500,000) using the format indicated in the bidding forms. The Bid Security must be valid until 31st May 2024. Late bids shall be rejected. Bids shall be virtually opened in the presence of bidders' representatives who choose to attend the online/virtual public bid opening session via Microsoft Teams Platform at 10:40am on 22nd November 2023. Bidders will be required to share email

addresses of their representatives to attend the online/virtual public bid opening session prior to submission of Bids.
