All bids must be accompanied by a Bid Securing Declaration using the format indicated in the bidding forms. The Bid Securing Declaration must be valid until 9th September 2024. Late bids shall be rejected. Bids shall be virtually opened in the presence of bidders' representatives who choose to attend the online/virtual public bid opening session via Microsoft Teams Platform at 11:00am on 29th January 2024. Bidders will be required to share email addresses of their representatives to attend the online/virtual public bid opening session prior to submission of Bids.
